BIOGRAPHICAL SKETCH

Judge Hugh C. Gilbert came to the Phoenix area from Kansas City, Missouri, in 1916. He was a construction engineer, involved with various reclamation projects in Colorado and Utah prior to his joining the Board of Governors of the Salt River Valley Water Users Association. Gilbert was instrumental in forming the Maricopa County Farm Bureau in 1920, and the Salt River Valley National Farm Loan Association in 1921. Gilbert served as President of both organizations. A Democrat, Judge Gilbert was elected as a State Senator from Maricopa County in 1922. A successful politician and civic leader, Gilbert was elected Chairman of the Maricopa County Board of Supervisors in 1928, and ran for State Treasurer in 1934.

SCOPE AND CONTENT

The Gilbert Collection consists primarily of Maricopa County government reports, as well as documents and correspondence relating to personal and business matters. The third series includes a variety of printed matter, some of which feature Gilbert's campaign advertising. The Hugh C. Gilbert Collection was acquired by AHF in 1975.
