BIOGRAPHICAL SKETCH

Sherman Hazeltine was born in Prescott, Arizona on August 13, 1907. His father, Moses Hazeltine, was President of the Bank of Arizona in that city. Sherman succeeded his father as President in 1948. His bank later merged with the First National Bank of Arizona, and in 1958 Sherman Hazeltine became the bank's CEO, holding that position until his retirement in 1977. He continued to serve as Chairman Emeritus of the bank's Board of Directors until his death in 1992. Mr. Hazeltine was very prominent in Phoenix business, charitable and social affairs, and served on the Board of Directors of the Arizona Historical Foundation.

SCOPE AND CONTENT NOTE

The Sherman Hazeltine Collection consists of papers and documents ranging from the 1870s to the 1950s, dealing with mining, banking, real estate and other Arizona topics. The materials do not, for the most part, relate to the personal or public affairs of Sherman Hazeltine, but were presumably collected by him and given to the Arizona Historical Foundation by his family. The Collection is divided into six series: (1) The Bull Dog Mining and Milling Association; (2) Arizona Mining Miscellany; (3) Banking; (4) Real Estate; (5) W.E. Hazeltine Correspondence; and (6) Miscellaneous. The materials on the Bull Dog Mine, all from 1895, contain correspondence and financial documents which shed light on the problems attendant to the start-up of a mining company. The planning process for the dedication of the First National Bank building in 1956 is documented in Series two, Banking. Abstracts for property in early Phoenix involving such prominent names as King Woolsey and James A. Reavis can be found in Series four, Real Estate. Unusual items in Series five, Miscellaneous, include a penny picture postcard commemorating ostrich culture in Arizona, a collar button patent from 1915, and a souvenir program of the celebration of the advent of the S.F. and P.P. Railroads to Phoenix in 1895.
