BIOGRAPHICAL NOTE: Frank L. Snell 1899 – 1994.

Frank L. Snell was born in Kansas City, Missouri on December 23, 1899. While working in his father's grocery store as a boy, young Frank attended the Kansas City public schools. In 1924 Mr. Snell received his law degree from the University of Kansas. Upon graduation Mr. Snell moved to Miami, Arizona where he established an independent practice upon the advice of his uncle. There in Miami Mr. Snell met and married Elizabeth Berlin. The couple had two children, daughter Kathryn and son Richard.

In 1927 Mr. and Mrs. Snell moved to Phoenix where Mr. Snell became a partner in the law firm of Elliot & Snell. In 1934 Mr. Elliot entered semi-retirement and Mr. Snell took over the practice. With the expansion of the law firm Mr. Snell decided it was time to seek an attorney with courtroom experience. Upon the recommendation of three Maricopa County Superior Court judges Mr. Snell formed a partnership with Mark Wilmer and established the law firm of Snell & Wilmer. Mr. Snell handled most of the business and commercial aspects of law while Mr. Wilmer was the firm's trial lawyer.

The Snell & Wilmer LLP Law Offices is still in existence today and includes offices in California, Utah, Colorado, and Nevada. During Mr. Snell's time with the law firm he led a group of citizens to secure the resignations of the Mayor and Chief of Police of Phoenix who were perceived as corrupt. The political situation threatened the growth of Phoenix which was increasing due to the influx of war veterans and their families. Mr. Snell also facilitated the merger of the state's two major utility companies to form the Arizona Public Service Company. He also acquired agreements for the firm's industrial clients outside Phoenix city limits. Finally, the firm handled one of the state's most important lawsuits, *Arizona v. California*, the United States Supreme Court, which secured Arizona rights to the waters of the Colorado River.

Mr. Snell's personal achievements are documented in the activities he participated in outside of Snell & Wilmer. It was soon after his move to Phoenix in 1927 that Mr. Snell became friends with Gene Pulliam (owner of *The Phoenix Gazette* and *The Arizona Republic*) and Walter Bimson, chief of Valley National Bank. These men would comprise the "Big Three" and would go on to found the Phoenix 40. With the establishment of these relationships Mr. Snell had a significant impact on Arizona's civic affairs. Some of his accomplishments include founding the American Graduate School of International Management and serving as chairman of the Civic Plaza Art Enrichment Committee. Mr. Snell also served as president, director, committee member and volunteer for many prominent Arizona organizations. His numerous awards include being one of the first inductees to the Arizona Business Hall of Fame in 1987. In 1992 Mr. Snell received the Arizona Heritage Award from the Arizona Chamber of Commerce.

While Mr. Snell reduced his role in Snell & Wilmer throughout the years he would still go to his office on a daily basis where he continued to participate in his organizational and volunteer work. In 1983 Mr. Snell lost his beloved wife, Betty, to cancer. He married Mary Jean Thompson in 1987 and welcomed her daughter Kirstin into the family. Mr. Snell passed away on September 5, 1994 at the age of 94. Mr. Snell was an active member of the community until two weeks before his death. He was survived by his wife Mary Jean, children Kathryn and Richard, step-daughter Kirstin, six grandchildren and two great grandchildren.
